1. You will receive quarterly wine shipments at the fixed price of \$65 with a retail value of \$75-\$100.
2. You will receive 20% discounting on Sort This Out Cellars wine purchases online at www.sortthisoutcellars.com, by fax, or by telephone.
3. You will have access to limited production wines and allocations that may not be available to the public.
4. You will receive a complimentary commemorative gift with each quarterly shipment.

Terms and Conditions

Subject to change without prior notice

1. "The List" is a subscription based wine club providing programmed wine shipments to members of "The List" four times a year.
2. To join the list you must be 21 years of age or older, complete the online application, and provide all the required information. This information will allow us to charge your credit card to complete your membership, ship your orders to the address of your choice (California Only), and comply with Federal and State laws.
3. Each shipment will cost \$65 plus applicable state sales tax (7.75%) and shipping charge (2-3 Bottles \$15, 4-6 Bottles \$19).
4. Sort This Out Cellars will place an order on your behalf four times a year, or approximately every 11-14 weeks. This order or "shipment" will include between 2-6 bottles of wine. Each shipment is selected at the discretion of Sort This Out Cellars and may not be exchanged or substituted for other Sort This Out Cellars products.
5. Your credit card will be charged up to 7 days prior to shipping the wine. You will not receive prior notice to the charging of your card. Sort This Out Cellars is not responsible for fees charged by your credit card provider as a result of this charge, including over limit fees.
6. The signature of an adult 21 years of age or older is required for delivery of your shipment. You may choose to have your wine shipped to a home or business address. You may not have your wine shipped to a P.O. Box. You will be charged to re-ship a shipment that has been returned to Sort This Out Cellars as undeliverable or declined by a third party. Please make sure you have the permission of your office or company to receive wine shipments at your business address.
7. Visa, MasterCard, American Express, and Discover credit cards are accepted as a form of payment. You may choose to use your Visa or MasterCard Debit Card for purchases however we recommend using a credit card. Returns and credits made to Debit Cards are subject to terms and conditions of your bank. Checks and COD are not accepted.
8. There are no initiation, membership, or cancellation fees. You may cancel your membership at anytime up to 7 days prior to the processing of a current shipment. You must communicate your wish to cancel your membership in "The List" by email to info@sortthisoutcellars.com or by phone (805) 688-1717.
9. We do not accept returns on "The List" Cellar Club shipments. All sales of Cellar Club wine shipments are final. We only accept exchanges of Cellar Club wine(s) for the same or like value wine(s) if the wine is damaged during shipping.
10. Your information transmitted online is kept secure. Personal data will be used exclusively by Sort This Out Cellars. It is your responsibility to notify us of changes to your billing and shipping information.
